2. The registered office of the Trust shall be at 2229/1291 and 2230/1291 Attibele Road, Sarjapura, Anekal Taluk, Bangalore district.
- 3 **OBJECTS :** The aims and objects of the Trust shall be :
 - A) Providing education by establishing and maintaining Educational Institution/s, Vocational Training centers, Hostels, Libraries, Reading Rooms etc.,
 - B) Providing financial or other assistance to needy or deserving students.
 - C) Relief to the needy.
 - D) Providing financial or other assistance to the needy, handicaps, the orphans, the destitute, the widows and the other disadvantaged and underprivileged sections of the society.
 - E) Providing Medical Relief to the public by establishing and maintaining Hospitals, Dispensary / ies, etc., and by conducting Medical Camps.

4. **IRREVOCABILITY :**

5. **TRUST PROPERTY :**

- Corpus created by the Authors by contribution.
- Contributions, Donations, Gifts, Endowments, Income and other amounts received by the Trust.
- Properties, Movable and Immovable, acquired by the Trust by transfer, taking over, assignment, purchases, Gift, Donation, Entrustment, Lease or by any other mode. Shall be the properties of the Trust.

6. **CONSTITUTION AND MANAGEMENT :-**

- The trustees named hereinabove shall hold office for their life of time, but the Trustee at any of them resign from the office of the Trustee at any time after giving advance notice of at least three months to the Board of Trustees.
- If any of the Trustees due to ill health, old age, absence / abstain from duties obligation continuously for a period of Six Months (6) or leave the country and stay abroad for longer duration in more than six months or for any other reasons whatsoever, the office of the said Trustee so shall be deemed to have fallen vacant, under the said circumstances the provisions of this trust deed relating to the succession to the office of the Trustee shall apply accordingly.
- During their lifetime, but prior to any even which renders them incapable of carrying on their duties as Trustees, all the Trustees can nominate one member of their respective families to succeed them as Trustees. The persons who succeed to the office of the Trustees in accordance with this clause in the aforesaid manner shall be Trustees for their lifetime and can also nominate their successors in the same manner. The Trustees at the first meeting nominated their respective nominees or Successors for this Trust.

- VI. The Total number of Trustees shall at no time exceed 10 (-) and shall never be less than 4 (-).
- VII. The office of the Trustees shall be honorary and the Trustees are not entitled to any remuneration for carrying out their duties. However, the expenditure incurred by the Trustees in carrying out the work of the Trust or in execution of the objects of the Trust including traveling expenditure etc., shall be reimbursed from the funds of the Trust.

7. **BOARD OF TRUSTEES :**

The Trustees shall be collectively referred to as the Board of Trustees and all the funds, property, rights, claims, demands of every description belonging to or pertaining to the Trust and which may acquired from time to time shall vest in the Board of Trustees.

8. **POWER OF TRUSTEES :**

Without prejudice to the generally of the POWERS VESTED IN THEM, the Board of Trustees shall have the following specific powers :

- a. To acquire by purchase, gift, grant, exchange, lease, or otherwise properties of all kinds, both movable and immovable and to convert one kind of property into another.
- b. To improve or to add to the corpus of the Trust.
- c. To sell, lease out or give on license or otherwise dispose of or alienate all or any of the properties of the Trust.
- d. To receive monies and to grant receipts and discharges thereof.

- e. To borrow monies from banks and other person for the purpose of executing the aims of the Trust.
- f. To institute, prosecute and defend all actions and proceedings and the like before the government, courts, tribunals, revenue, municipal and local authorities, tax authorities, etc., and to represent the Trust before them.
- g. To enter into any compromise and to refer matters to arbitration.
- h. To engage the services of any person or persons on such remuneration as the Trustees deem, fit and to terminate their services as also alter the terms of their services.
- i. To incur all the costs and expenses for the due and efficient management of the affairs and properties of the Trust.
- j. To invest all the Trust funds in any form or mode specified under the provisions of section 13(1)(d) read with section 11(5) of the Income Tax Act, 1961 as amended from time to time.
- k. To frame rules and policies for the proper administration of the Trust in conformity with the above powers, to vary them and to do all the other things as are incidental, conducive and expedient to the attainment of the objects of the Trust.
- l. Identification/selection of the needy or deserving beneficiaries shall be at the discretion of the Board of Trustees.
- m. The Trustees shall keep and maintain the Trust property/properties in safe and good condition and shall make all efforts for its development and proper use of the said in achieving the objects of the Trust.

The aforesaid powers may be exercised by the Trustees who constitute the "BOARD OF TRUSTEES" jointly or severally as the "BOARD OF TRUSTEES" may decide from time to time.

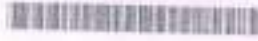
